# THE FAR RIGHT CAN'T BE FOUGHT BY LEADING ITS MIGRATION POLICY

The Darmanin Law of January 26, 2024, the Retailleau Circular of January 23, 2025, a draft 2026 finance bill that includes an increase in taxes on migrants applying for a residence permit and the elimination of housing benefits for international students, a draft decree restricting access to state medical aid (AME), and let's not forget the vote on the proposed resolution to "denounce" the Franco-Algerian agreement on October 30, 2025: migration policy in France continues to stigmatize, impoverish, and oppress migrants! And yet, what do these migrants want? To have a residence permit to guarantee their right to work, housing, education, healthcare, etc., and thus facilitate their integration into society! But such a request seems untenable for the government, which systematically chooses to tighten access to these residence permits, with the complicity of the far right it claims to fight. And the "pull factor" argument cannot hold water when the migrants, interviewed by associations and unions, prefer to stay here rather than leave for Spain, where the reception policy seems to have a different direction!

Here in Poitiers, this discriminatory migration policy is clearly visible, as throughout France, deportation orders (OQTF - Obligation to Leave French Territory) are

raining down and have more than doubled since 2017 (140,000 OQTFs across France in 2024)! This year, in 2025, 17 undocumented workers out of the 20 members of the collective of undocumented delivery drivers in Poitiers received an OQTF from the prefecture, following the submission of their application for a residence permit on March 22, 2025, which was followed by a demonstration gathering more than 500 people ! Deportation orders are purely administrative decisions and are not linked to any crime, and undocumented workers are therefore bearing the brunt of this far-right-inspired immigration policy, including when these workers are employed in sectors where few French citizens work : food delivery, agriculture, catering, construction, cleaning, the food industry...

Faced with this scandalous injustice, and faced with the rise of the far right and its hateful ideas, let's mobilize in Poitiers and throughout France to support migrants, and let's support the collective of undocumented workers in Poitiers! Their struggle is everyone's struggle: it is a struggle against the far right and its ideas, and against the precariousness of undocumented workers, which erodes the social rights of everyone.
